TO: STANLEY PINKUS, DDS, Respondent:

PLEASE BE ADVISED on or about the 22rd day of December, 2011, a Complaint was filed with the Nevada State Board of Dental Examiners (the "Board") seeking disciplinary action against your license to practice dentistry in the State of Nevada.

YOU ARE FURTHER ADVISED the Board has scheduled a public hearing to consider the allegations contained in the Complaint. The public hearing is scheduled to commence on **Friday 3, 2012, at 9:00 AM** at the offices of the Nevada State Board of Dental Examiners, 6010 S. Rainbow Boulevard, Suite A-1, Las Vegas, Nevada 89118. If necessary, the hearing shall continue to February 4, 2012 beginning at 8:30 am.

YOU ARE FURTHER ADVISED the hearing will be held pursuant to Nevada Revised Statutes ("NRS") chapters 233B, 622A, and 631 and Nevada Administrative Code ("NAC") chapter 631. The purpose of the hearing is to consider evidence regarding the allegations in the Complaint and to determine whether Respondent should be subject to discipline pursuant to NRS and NAC chapters 631.

YOU ARE FURTHER ADVISED the hearing is to be an open meeting under Nevada's

1 Open Meeting Law and may be attended by the public. During the hearing, the Board may
2 choose to go into closed session to consider the character, alleged misconduct, professional
3 competence, or physical or mental health of Respondent. A verbatim record will be made by a
4 court reporter. You are entitled to a copy of the transcript, at your cost, of the open and closed
5 portions of the hearing.

7 **YOU ARE FURTHER ADVISED** you have the right to answer the Complaint. You
8 have the right to appear and be heard at the hearing in your defense, either personally or through
9 counsel of your choice, at your cost. At the hearing, the Board has the burden of proving the
10 allegations in the Complaint and can call witnesses and offer exhibits/evidence regarding the
11 allegations in the Complaint.

13 **YOU ARE FURTHER ADVISED** if a violation is found and discipline is imposed, the
14 Board may also recover reasonable attorney's fees and costs pursuant to NRS 622.400.
15

16 **YOU ARE FURTHER ADVISED** you have the right to call and examine witnesses,
17 offer exhibits/evidence, and cross-examine opposing witnesses or any matter relevant to the
18 issues involved.
