Request for the Advisory Opinion regarding whether applicant Antonina Capurro, DMD meets the requirements for dental hygiene licensure pursuant to NRS 631.290 and NRS 631.300

#### **ADVISIORY OPINION**

### I. BACKGROUND

1. As set forth in NAC 631.279 through authority of NRS 631.190 and NRS 233B.120 the Board is authorized to provide advisory opinions.

NAC 631.279 Proceedings to determine applicability and construction of statutes and regulations. (NRS 631.190)

- A. The Board has discretion whether or not to issue an advisory opinion pursuant to NAC 631,279.
- B. Applicant, Antonina Capurro, DMD requested an advisory opinion regarding whether she meets the requirements for dental hygiene licensure pursuant to NRS 631.290 and NRS 631.300 and request a letter be submitted to the Western Regional Examining Board on her behalf.
- C. Public notice of the above-referenced request for an advisory opinion was provided in accordance with state law.

## II. DISCUSSION

D. Dr Capurro requested an advisory opinion regarding whether she meets the requirements for dental hygiene licensure pursuant to NRS 631.290 and NRS 631.300. Pursuant to NRS 241.030, Dr Capurro requested to go into close session due to discussion related to her physical health. (Closed Session)

Board Counsel read into the record all provisions set forth in NRS 631.290. NRS 631.290 states:

NRS 631.290 Dental hygienists. Eligibility to apply for license.

- 1. Any person is eligible to apply for a license to practice dental hygiene in this State who.
- (a) Is of good moral character;
- (b) Is over 18 years of age;
- (c) Is a citizen of the United States or is lawfully entitled to remain and work in the United States; and
- (d) Is a graduate of a program of dental hygiene from an institution which is accredited by a regional educational accrediting organization that is recognized by the United States Department of Education. The program of dental hygiene must.
  - (1) Be accredited by the Commission on Dental Accreditation of the American Dental Association or its successor specialty accrediting organization; and
- (2) Include a curriculum of not less than 2 years of academic instruction in dental hygiene or its

academic equivalent.

2. To determine whether a person has good moral character, the Board may consider whether his or her license to practice dental hygiene in another state has been suspended or revoked or whether he or she is currently involved in any disciplinary action concerning his or her license in that state.

Board Counsel advise pursuant to NRS 631.2901(d) the applicant *must* be a graduate of a program of dental hygiene from an institution which is accredited by a regional educational accrediting organization that is recognized by the United States Department of Education, be accredited by the Commission on Dental Accreditation of the American Dental Association or its successor specialty accrediting organization; and the curriculum of not less than two (2) years of academic instruction in dental hygiene or its academic equivalent. The presence of the word "must" is the authority as being compulsory and mandatory.

Therefore, it is the legal opinion of Board Counsel that applicant Antonina Capurro, DMD does not meet the eligibility requirements as set forth in NRS 631.290 and the requested letter should not be issued by the Board to the Western Regional Examining Board indicating she is eligible to participate in their dental hygiene clinical examination.

Board Counsel then advised to the Board Members the proper language necessary to issue an advisory opinion.

# III. CONCLUSION

After considering and discussing public comment pursuant to the authority set forth in NAC 631.279, NRS 631.190 and NRS 233B.120, a motion was made by Board Member Solie that the Board issue an opinion Antonina Capurro, DMD does not meet the eligibility requirements as set forth in NRS 631.290 and therefore the Board cannot issue a letter to the Western Regional Examining Board on Antonina Capurro, DMD behalf.
