I immediately contacted Dr. Smith to inform her of my receipt of the Board's documents, and spoke with her on March 14, 2018, to advise her of the filing which she was unaware of and of the hearing date. Dr. Smith informed me that she would be leaving Las Vegas to travel to Texas and would not be returning until the last week of March. I have further been informed that now she will not be returning until the second week of April which is after the date scheduled for the formal hearing.

Likewise, prior to receiving the Board's Notice of Hearing, I previously scheduled to be out of state on the 6th and 7th of April, and thus unavailable for the scheduled hearing. I have a tentative scheduled jury trial to commence anywhere from the 16th of April until May 18th 2018, which should last between four and five days. I am sure that a date which is convenient to counsel for the Board, the Board, Dr. Smith and Dr. Smith's counsel can be agreed upon to schedule the Formal Hearing.
