#### For agenda item 9 (b):

The NDHA would like to voice concerns that the Subcommittee on Dental Hygiene and Dental Therapy has, to date, failed to become a fully functioning subcommittee and has still not held adequate meetings to discuss the proposed dental therapy language. The subcommittee was formed with the intent to utilize dental therapy content experts to assist in the implementation of dental therapy and to assist in drafting language. This subcommittee is still in the process of being formed with the addition of new members, mission statement work, and assignments. It is our request to postpone adoption of any dental therapy language until the Committee and Subcommittee has had the opportunity to thoroughly discuss the proposed language.

#### For agenda item 9 (g):

As the NSBDE considers new board appointments for committee positions in 2021, it is with much respect that NDHA continue to reasonably request that the chair of the Committee on Dental Hygiene and Dental Therapy be a licensed dental hygienist. In the past, the NSBDE has had one of their dental hygienist board members chair this committee (i.e.: Ms. Pate (2019), Ms. Gabriel (2018), Ms. Guillen (2015-2017), etc.). Therefore, the NDHA is in support of Ms. Solie to receive consideration for the 2021 chair position based on her experience as a dental hygienist serving on various national and local committees, and her past knowledge as a NSBDE board member who has served on this committee before.

#### a. Minutes

(4) Infection Control Committee Meeting -12/02/2020 (Public book page 24)

The minutes are confusing, and I believe inaccurate in item #5 Review, discussion and consideration of whether Public Health Dental Hygiene Program is abiding by Covid-19 Infection Control Requirements and possible recommendation to the board to approve/reject the program - NAC 631.210. Within the paragraph references are made to both the Senior Smiles program and the Heavenly Smiles Mobile Dental Program. It is not clear in the minutes what entity was being discussed - please clarify and rectify.

b. <u>Discussion</u>, <u>consideration</u> and <u>possible approval/rejection of the Committee on Dental</u>

<u>Hygiene and Dental Therapy's recommendation to appoint members to the Public Health Dental</u>

<u>Hygiene and Dental Therapy Subcommittee</u>

Appointment to the Public Health Dental Hygiene and Dental Therapy Subcommittee should be reserved for those with expertise and experience in public health dental hygiene and dental therapy. It is crucial to utilize content experts while developing the NACs for dental therapy in Nevada. Other dentists, dental hygienists, and members of the public who may have an interest in these policies, while not recommended for appointment to the subcommittee, still have an avenue for providing input through public comment during workshops, committee meetings, and board meetings. The NDHA requests that appointments to the subcommittee be based on expertise, not interest.
