To the Nevada State Board of Dental Examiners,

The Washoe County Health District strongly supports the Review of Nevada Administrative Code Chapter 631 related to the practice of dentistry and proposed emergency regulations pertaining to the administration of vaccinations by licensed dental professionals (NAC 631.2270-2285).

During this unprecedented time, it is imperative that the state of Nevada permit and support the efforts of this specialty healthcare workforce to aid in the inoculation efforts for the COVID-19 vaccine. Permitting licensed dental professionals to administer vaccines will support the emergency public health response throughout the state by increasing access and opportunity.

Nationwide, the American Dental Association supports dental professionals administering the vaccine. The majority of our neighboring states have passed this emergency measure, most recently licensed dentists in the state of California will begin administering the COVID-19 vaccine on January 11, 2021.
