***a. Discussion, consideration, and possible recommendations to the Board regarding approval/rejection of Laser Proficiency Program** – NAC 631.035 (For Possible Action)

- (1) Dental Laser Coaching – "A Comprehensive Dental Laser Technology Overview with Clinical Keys to Optimize Laser Utilization Safely and Effectively" – (6 units)

Dr. Lemon stated that there were some concerns regarding the clinical portion of the Dental Laser Coaching course, namely, who would be conducting hands-on demonstration.

Dr. Park inquired as to whether there were any additional proctors on the paperwork.

Ms. Arias noted that hygienists can be included in the course.

1 Dr. Moore made a motion to recommend approval of the course to the Board in light of the updated
2 paperwork provided by Mr. Clausen. Ms. Arias seconded the motion.
3 Mr. Clausen joined the session. Dr. Lemon requested that the motion to approve be postponed until
4 Mr. Clausen could address the concerns and invited Mr. Clausen to describe his proposal.
5 Mr. Clausen stated that he had consulted with Dr. William Leavitt at the University of Nevada-Las Vegas
6 School of Dental Medicine to discuss the clinical portion of the course. Dr. Leavitt agreed to provide the
7 clinical demonstration for the course.
8 Ms. Arias inquired whether there were any secondary providers ready to stand in if Dr. Leavitt became
9 unavailable.
10 Mr. Clausen noted that although he did not have any firm secondary providers, he has a list of other
11 practitioners whom he could reach out to stand in for Dr. Leavitt if necessary.
12 Dr. Park thanked Mr. Clausen for the clarification and for compiling the list of practitioners for the course.
13 Dr. Moore noted that when the Committee recommends the Board approve the course, Mr. Clausen would
14 need to be ready to notify the Board of any changes in clinical demonstrators and would need to update
15 the paperwork accordingly.
16 Dr. Moore renewed the motion to recommend approval of the course to the Board. Ms. Arias seconded the
17 motion. All were in favor. Motion passed.
