Dr. Moore introduced this agenda item and requested Mr. Su to give a brief overview. Mr. Su provided a summary of the proposed regulation changes as well as the history behind the proposed changes. Dr. Moore invited the Committee and Sub-Committee members to offer their thoughts and suggestions. Discussion ensued among Dr. Okundaye, Dr. Thompson, Dr. Moore, Dr. Saxe, Dr. Miller, and Dr. Twesme regarding modifications to Section 12 for 631.2227. The Committee and Sub-Committee members agreed on certain adjustments to Subsection 8 within Section 12.

No changes were suggested for the proposed draft of Section 13 for 631.2227, so discussion continued among Dr. Moore, Dr. Saxe, Dr. Okundaye, Dr. Twesme, and Dr. Miller regarding potential modifications to Section 14 for 631.2227. The Committee and Sub-Committee members agreed on certain adjustments to Subsection 2 within Section 14.

No changes were suggested for the proposed draft of Section 15 for 631.2227.

Dr. West made a motion to accept the changes as discussed and to recommend the changes to the full Board. Dr. Moore seconded the motion. All were in favor. Motion passed.
