- NAC 631.030 Provision of certain information and documentation by applicant for licensure; provision of certain additional information for licensure by endorsement; requirements for use of laser radiation in practice
- 2) NAC 631.___ Dental Therapists: Eligibility to apply for license; educational requirements
- 3) NAC 631.___ Examination for license to practice dental therapy
- 4) NAC 631.___ "Direct Supervision" defined for purposes of NRS 631.3122
- 5) NAC 631.___ Required provisions of dental therapy written practice agreement
- 6) NAC 631.___ Requirements of authorizing dentist supervising a dental therapist
- 7) NAC 631.___ Notification to dental therapist if authorizing dentist is under board investigation
- 8) NAC 631. Dental therapists: Authorization to perform certain services; referral of patient

to authorizing dentist for certain purposes
