196 Dr. Moore introduced Mr. Almeida and Ms. Jennifer Brown, CRNA.

Mr. Almeida and Dr. Miller participated in a slide show presentation to the AADB called "The CRNA and
Safety". Michael Almeida is located in Illinois and is the President of the Illinois Association of Nurse
Anesthetist (NA).

- 200 Mr. Almeida stated there are about 50,000 CRNA's throughout the country, and administer annually
- approx. 50 million anesthetics. The education starts with a bachelor's in nursing in an intensive care setting
- for a minimum of 1 year, and the average is 3.5 years. The approximate length of a CRNA program is 2.5
- years. By 2025 all CRNA's will be at the doctoral level. Mr. Almeida went over safety slides, scope of
- 204 practice laws, safety research and policy brief. NA's have been providing anesthesia in the US for more 205 than 150 years. Mr. Almeida presented a map of State Dental board permits for CRNA. Mr. Almeida went

 over the legal responsibility. Mr. Almeida went over cost effectiveness.

- 208 Jennifer Brown is the President of Nevada Association of Nurse Anesthetists (NVANA).
- 209 Ms. Brown stated the board of nursing first adopted regulations establishing standards and authorization
- 210 functions in 1986 for CRNA's. CRNA's are authorized to administer anesthetic agents to a person under
- the care of a licensed physician, dentist, or podiatrist. Ms. Brown stated that there are no supervision
- requirements and there are no state or federal requirements for CRNA's to administer anesthetics, so
- 213 CRNA's have complete authority to control, administer, and direct anesthesia in the state of Nevada.
- Dr. Thompson stated that it is not currently legal to have a CRNA perform anesthesia in a general
- 215 practice.
- 216 Chairman Moore asked if there were any questions for Ms. Brown.
- 217 Dr. Thompson asked if the CRNA had to be under supervision of a physician or dentist.
- 218 Ms. Brown said that the patient had to be under the care of the physician or dentist. The dentist has to
- 219 hold a permit for general anesthesia. The dentist is required to supervise the CRNA.
- 220 Ms. Brown stated a lot of CRNA's are out of Utah and provide anesthesia to pediatric and outpatient
- dental patients. Ms. Brown was hoping there could be some language change to the laws and that the board would consider it.

- Dr. Moore stated that a few Board members with quite a bit of experience may have some input on the

- 226 Dr. Twesme stated that he had gathered information about regulation in every state west of the
- 227 Mississippi. He believes that CRNA would not be able to deal with an emergency situation such as a
- tracheotomy and does not feel that the regulations should change; he is opposed to the change.
- Jennifer Brown responded that Nurse Anesthetists are trained in dentistry such as pediatrics and
- 230 understands that experience; she said you have to choose the correct Nurse Anesthetist.
- Dr. Twesme asked about Nurse Anesthetist and a Tracheotomy.
- Jennifer Brown referred to Mr. Almeida for his opinion.
- 233 Mr. Almeida stated that you could poll thousands of anesthesia providers ask them how many have done 234 a tracheotomy and you might have 1 person who says they have done one in their career and it is very
- 235 rare.
- 236 Dr. Okundaye stated that there is no mobile component. She stated there was always a team. There is a
- physician anesthesiologist or dentist present for backup due to level of education, training or experience.
- 238 Sharing an airway is different. Malpractice is another component. The CRNA in the North Carolina case

- 239 was not held liable but the dentist was held liable. Doctors do not know what questions to ask CRNA's to
- 240 know how qualified they are. Arizona has had 3 deaths with CRNA's.
- 241 Dr. Moore opened the floor for more questions.
- 242 Dr. West asked Dr. Okundaye if there is a mobile component when you are trained.
- Dr. Okundaye said yes it is written in CODA that there has to be 1 year of training on a mobile unit in adental practice.
- 245 Dr. Gray has been an anesthesia evaluator for a very long time. He feels that he does not have the
- authority to cerify the skill level of a CRNA. He states that you are generally alone while working and
- 247 dentistry is unique because you share the airway. He feels there are a lot of downsides and he has
 248 reservations.
- Dr. Miller, a Pediatric dentist, made a statement that the pediatrics brings a complexity to this issue. There
 are patient selection issues. He worries that backup won't be there in time of need.
- Dr. Thompson would like to know statistics. How many are being underserved? Are their needs being met?
- 253 Dr. Saxe wanted to know where the training was done. Have you gone out to an office and done it 254 during your training or have you only done it in a hospital setting?
- 255 Jennifer Brown said that she worked in a hospital setting with pediatric dentistry.
- 256 Ms. Brown commented that you were always being supervised by an anesthesiologist at the hospital.
- 257 Ms. Brown stated that during training that is true but since graduation she has been independent.
- 258 Dr. Saxe said that back up was a concern.
- Dr. West stated that he understands that pediatrics is a very large part of the CRNA work and did shethink a dental component could be added to NA training.
- Dr. Okundaye stated that NA's should see a minimum 30 pediatric patients aged 2-12 years ideally 75 to graduate. Dr. Moore said that there needs to be more information. This is an access to care issue. There needs to be some statistics and some specifics of the CRNA training and asked Dr. Okundaye to prepare a comparison for consideration at the next meeting.

The provisions of this chapter do not affect or limit the authority of a regulatory body, at any stage of a contested case, to make an informal disposition of the contested case pursuant to subsection 5 of <u>NRS 233B.121</u> or to enter into a consent or settlement agreement approved by the regulatory body pursuant to <u>NRS 622.330</u>.

2. The provisions of this chapter do not affect or limit the authority of a regulatory body to designate a panel of its members to hear a contested case pursuant to this chapter.

NRS 622.330 Consent and settlement agreements: Conditions for entry; deemed public records; exceptions.

1. Except as otherwise provided in this section, a regulatory body may not enter into a consent or settlement agreement with a person who has allegedly committed a violation of any provision of this title which the regulatory body has the authority to enforce, any regulation adopted pursuant thereto or any order of the regulatory body, unless the regulatory body discusses and approves the terms of the agreement in a public meeting.

2. A regulatory body that consists of one natural person may enter into a consent or settlement agreement without complying with the provisions of subsection 1 if:

(a) The regulatory body posts notice in accordance with the requirements for notice for a meeting held pursuant to <u>chapter 241</u> of NRS and the notice states that:

(1) The regulatory body intends to resolve the alleged violation by entering into a consent or settlement agreement with the person who allegedly committed the violation; and

(2) For the limited time set forth in the notice, any person may request that the regulatory body conduct a public meeting to discuss the terms of the consent or settlement agreement by submitting a written request for such a meeting to the regulatory body within the time prescribed in the notice; and

(b) At the expiration of the time prescribed in the notice, the regulatory body has not received any requests for a public meeting regarding the consent or settlement agreement.

3. If a regulatory body enters into a consent or settlement agreement that is subject to the provisions of this section, the agreement is a public record.

4. The provisions of this section do not apply to a consent or settlement agreement between a regulatory body and a licensee that provides for the licensee to enter a diversionary program for the treatment of an alcohol or other substance use disorder.

Agenda Item 6(a): NAC 631.173

NAC 631.173 Continuing education: Required hours; types of courses and activities; approval of provider or instructor. (NRS 631.190, 631.342)

1. Each dentist licensed to practice in this State must annually complete at least 20 hours of instruction in approved courses of continuing education or biennially complete at least 40 hours of instruction in approved courses of continuing education, as applicable, based on the renewal period set forth in <u>NRS 631.330</u> for the type of license held by the dentist. Hours of instruction may not be transferred or carried over from one licensing period to another.

2. Each dental hygienist licensed to practice in this State must annually complete at least 15 hours of instruction in approved courses of continuing education or biennially complete at least 30 hours of instruction in approved courses of continuing education, as applicable, based on the renewal period set forth in <u>NRS 631.330</u> for the type of license held by the dental hygienist. Hours of instruction may not be transferred or carried over from one licensing period to another.

3. In addition to the hours of instruction prescribed in subsections 1 and 2, each dentist and dental hygienist must maintain current certification in administering cardiopulmonary resuscitation or another medically acceptable means of maintaining basic bodily functions which support life. Any course taken pursuant to this subsection must be taught by a certified instructor.

4. Any provider of or instructor for a course in continuing education relating to the practice of dentistry or dental hygiene which meets the requirements of this section must be approved by the Board, unless the course is for training in cardiopulmonary resuscitation or is approved by:

(a) The American Dental Association or the societies which are a part of it;

- (b) The American Dental Hygienists' Association or the societies which are a part of it;
- (c) The Academy of General Dentistry;
- (d) Any nationally recognized association of dental or medical specialists;
- (e) Any university, college or community college, whether located in or out of Nevada; or
- (f) Any hospital accredited by The Joint Commission.

5. To be approved as a provider of a course in continuing education, the instructor of the course must complete a form provided by the Board and submit it to the Board for review by a committee appointed by the Board not later than 45 days before the beginning date of the course. Upon receipt of the form, the committee shall, within 10 days after receiving the form, approve or disapprove the application and inform the applicant of its decision.

6. Study by group may be approved for continuing education if the organizer of the group complies with the requirements of subsection 5 and furnishes the Board with a complete list of all members of the group, a synopsis of the subject to be studied, the time, place and duration of the meetings of the group, and the method by which attendance is recorded and authenticated.

NAC 631.178 Adoption by reference of certain guidelines; compliance with guidelines required. (NRS 631.190)

1. Each person who is licensed pursuant to the provisions of <u>chapter 631</u> of NRS shall comply with:

(a) The provisions of the *Guidelines for Infection Control in Dental Health-Care Settings-2003* adopted by the Centers for Disease Control and Prevention which is hereby adopted by reference. The publication is available, free of charge, from the Centers for Disease Control and Prevention at the Internet address

(b) As applicable to the practice of dentistry, the provisions of the *Guideline for Disinfection and Sterilization in Healthcare Facilities, 2008*, adopted by the Centers for Disease Control and Prevention which is hereby adopted by reference. The publication is available, free of charge, from the Centers for Disease Control and Prevention at the Internet address http://www.cdc.gov/ncidod/dhqp/pdf/guidelines/Disinfection_Nov_2008.pdf.

2. The Board will periodically review the guidelines adopted by reference in this section and determine within 30 days after the review whether any change made to the guidelines is appropriate for application in this State. If the Board does not disapprove a change to the guidelines within 30 days after the review, the change is deemed to be approved by the Board.

7. Credit may be allowed for attendance at a meeting or a convention of a dental and dental hygiene society.

8. Credit may be allowed for courses completed via home study, on-line study, self-study or journal study which are taught through correspondence, webinar, compact disc or digital video disc.

9. Credit may be allowed for dental and dental hygiene services provided on a voluntary basis to nonprofit agencies and organizations approved by the Board.

Agenda Item 7(b): NAC 631.2235

NAC 631.2235 Inspections and evaluations: Grading; report of recommendation of evaluator; issuance of permit for passing; failure to pass; request for reevaluation; issuance of order for summary suspension. (<u>NRS 631.190</u>, <u>631.265</u>)

1. The persons performing an inspection or evaluation of a dentist and his or her office for the issuance or renewal of a general anesthesia permit or moderate sedation permit shall grade the dentist as passing or failing to meet the requirements set forth in <u>NAC 631.2219</u> to <u>631.2231</u>, inclusive. Within 72 hours after completing the inspection or evaluation, each evaluator shall report his or her recommendation for passing or failing to the Executive Director, setting forth the details supporting his or her conclusion.

2. If the dentist meets the requirements set forth in <u>NAC 631.2219</u> to <u>631.2231</u>, inclusive, the Board will issue the general anesthesia permit or moderate sedation permit, as applicable.

3. If the dentist does not meet the requirements set forth in <u>NAC 631.2219</u> to <u>631.2231</u>, inclusive, the Executive Director shall issue a written notice to the dentist that identifies the reasons he or she failed the inspection or evaluation.

4. A dentist who has received a notice of failure from the Board pursuant to subsection 3:

(a) Must cease the administration of any general anesthesia, deep sedation or moderate sedation until the dentist has obtained the general anesthesia permit or moderate sedation permit, as applicable; and

(b) May, within 15 days after receiving the notice, request the Board in writing for a reevaluation. The request for a reevaluation must state specific grounds supporting it.

5. If the reevaluation is granted by the Board, it will be conducted by different persons in the manner set forth by <u>NAC 631.2219</u> to <u>631.2231</u>, inclusive, for an original evaluation.

6. No dentist who has received a notice of failing an inspection or evaluation from the Board may request more than one reevaluation within any period of 12 months.

7. Pursuant to subsection 3 of <u>NRS 233B.127</u>, if an inspection or evaluation of a dentist or his or her office indicates that the public health, safety or welfare imperatively requires emergency action, the President of the Board may, without any further action by the Board, issue an order of summary suspension of the license of the dentist pending proceedings for revocation or other action. An order of summary suspension issued by the President of the Board must contain findings of the exigent circumstances which warrant the issuance of the order of summary suspension. The President of the Board shall not participate in any further proceedings relating to the order.

<u>Agenda item 7(c):</u> Consideration of Application to Reactivate Inactive License NAC 631.170

NAC 631.170 Placement of license on inactive, retired or disabled status; reinstatement. (NRS 631.190, 631.335)

1. A licensee may request the Board to place his or her license in an inactive or retired status. Such a request must be made in writing and before the license expires.

2. The Secretary-Treasurer may reinstate an inactive license upon the written request of an inactive licensee who has maintained an active license and practice outside this State during the time his or her Nevada license was inactive. To reinstate the license, such an inactive licensee must:

(a) Pay the appropriate renewal fees;

(b) Provide a list of his or her employment during the time the license was inactive;

(c) Report all claims of unprofessional conduct or professional incompetence against him or her or any violation of the law which he or she may have committed, including administrative disciplinary charges brought by any other jurisdiction;

(d) Report whether he or she has been held civilly or criminally liable in this State, another state or territory of the United States or the District of Columbia for misconduct relating to his or her occupation or profession;

(e) Report any appearance he or she may have made before a peer review committee;

(f) Submit proof of his or her completion of an amount of continuing education, prorated as necessary, for the year in which the license is restored to active status;

(g) Provide certification from each jurisdiction in which he or she currently practices that his or her license is in good standing and that no proceedings which may affect that standing are pending;

(h) Satisfy the Secretary-Treasurer that he or she is of good moral character; and

(i) Provide any other information which the Secretary-Treasurer may require,

 \rightarrow before the license may be reinstated. In determining whether the licensee is of good moral character, the Secretary-Treasurer may consider whether the license to practice dentistry in another state has been suspended or revoked or whether the licensee is currently involved in any disciplinary action concerning the license in that state.

3. If a person whose license has been on inactive status for less than 2 years has not maintained an active license or practice outside this State, or if a person's license has been on retired status for less than 2 years, he or she must submit to the Board:

(a) Payment of the appropriate renewal fees;

(b) A written petition for reinstatement that has been signed and notarized;

(c) Proof of his or her completion of an amount of continuing education, prorated as necessary, for the year in which the license is restored to active status; and

(d) A list of his or her employment, if any, during the time the license was on inactive or retired status,

 \rightarrow before the license may be reinstated.

4. If a person whose license has been on inactive status for 2 years or more has not maintained an active license or practice outside this State, or if a person's license has been on retired status for 2 years or more, he or she must:

(a) Satisfy the requirements set forth in paragraphs (a) to (d), inclusive, of subsection 3; and

(b) Pass such additional examinations for licensure as the Board may prescribe,

 \rightarrow before the license may be reinstated.

5. If the license of a person has been placed on disabled status, the person must:

(a) Satisfy the requirements of paragraphs (a), (b) and (c) of subsection 3;

(b) Submit to the Board a list of his or her employment, if any, during the time the license was on disabled status;

(c) Pass such additional examinations for licensure as the Board may prescribe; and

(d) Submit to the Board a statement signed by a licensed physician setting forth that the person is able, mentally and physically, to practice dentistry,

 \rightarrow before the license may be reinstated.

NRS 631.350 Authorized disciplinary or other action; grounds; delegation of authority to take disciplinary action; deposit of fines; claim for attorney's fees and costs of investigation; private reprimands prohibited; orders imposing discipline deemed public records. [Effective January 1, 2020.]

1. Except as otherwise provided in <u>NRS 631.271</u>, <u>631.2715</u> and <u>631.347</u>, the Board may:

(a) Refuse to issue a license to any person;

(b) Revoke or suspend the license or renewal certificate issued by it to any person;

(c) Fine a person it has licensed;

(d) Place a person on probation for a specified period on any conditions the Board may order;

(e) Issue a public reprimand to a person;

(f) Limit a person's practice to certain branches of dentistry;

(g) Require a person to participate in a program relating to an alcohol or other substance use disorder or any other impairment;

(h) Require that a person's practice be supervised;

(i) Require a person to perform community service without compensation;

(j) Require a person to take a physical or mental examination or an examination of his or her competence;

(k) Require a person to fulfill certain training or educational requirements;

(1) Require a person to reimburse a patient; or

(m) Any combination thereof,

 \rightarrow if the Board finds, by a preponderance of the evidence, that the person has engaged in any of the activities listed in subsection 2.

2. The following activities may be punished as provided in subsection 1:

(a) Engaging in the illegal practice of dentistry, dental hygiene or dental therapy;

(b) Engaging in unprofessional conduct; or

(c) Violating any regulations adopted by the Board or the provisions of this chapter.

3. The Board may delegate to a hearing officer or panel its authority to take any disciplinary action pursuant to this chapter, impose and collect fines therefor and deposit the money therefrom in banks, credit unions, savings and loan associations or savings banks in this State.

4. If a hearing officer or panel is not authorized to take disciplinary action pursuant to subsection 3 and the Board deposits the money collected from the imposition of fines with the State Treasurer for credit to the State General Fund, it may present a claim to the State Board of Examiners for recommendation to the Interim Finance Committee if money is needed to pay attorney's fees or the costs of an investigation, or both.

5. The Board shall not administer a private reprimand.

6. An order that imposes discipline and the findings of fact and conclusions of law supporting that order are public records.

NRS 631.190 Powers and duties. [Effective January 1, 2020.] In addition to the powers and duties provided in this chapter, the Board shall:

1. Adopt rules and regulations necessary to carry out the provisions of this chapter.

2. Appoint such committees, review panels, examiners, officers, employees, agents, attorneys, investigators and other professional consultants and define their duties and incur such expense as it may deem proper or necessary to carry out the provisions of this chapter, the expense to be paid as provided in this chapter.

3. Fix the time and place for and conduct examinations for the granting of licenses to practice dentistry, dental hygiene and dental therapy.

4. Examine applicants for licenses to practice dentistry, dental hygiene and dental therapy.

5. Collect and apply fees as provided in this chapter.

6. Keep a register of all dentists, dental hygienists and dental therapists licensed in this State, together with their addresses, license numbers and renewal certificate numbers.

7. Have and use a common seal.

8. Keep such records as may be necessary to report the acts and proceedings of the Board. Except as otherwise provided in <u>NRS 631.368</u>, the records must be open to public inspection.

9. Maintain offices in as many localities in the State as it finds necessary to carry out the provisions of this chapter.

10. Have discretion to examine work authorizations in dental offices or dental laboratories.
