(1) Additional Regulations Regarding Administration of Board Disciplinary Proceedings

Dr. Johl introduced the agenda item by requesting Committee members to offer input relating to the above agenda item. Discussion ensued among Dr. Park, Mr. Dworin, Dr. Lee, Dr. Johl, and Ms. Sull regarding the response time for disciplinary complaint notices, mailing details, and the addition of language to include dental therapists.

5 Dr. Lee made a brief statement summarizing the objective of the proposed regulatory language,

6 including an outline of a new proposed process for the intake of complaints. Additional discussion was

held among Mr. Pontoni, Dr. Johl, Dr. Lee, and Dr. Park regarding language details. Dr. Lee requested
input from Committee members regarding the professional title of the clinical review position to be

included in the regulatory language. Discussion ensued among Dr. Park, Dr. Lee, Dr. Johl, Mr. Dworin, Ms.

Sull, Mr. Pontoni, and Ms. McIntyre regarding options as to the title. The Committee members agreed to postpone the decision regarding the title for the time being.

Dr. Park made a motion to approve the second version of the proposed draft with the changes and corrections as discussed. Ms. McIntyre seconded the motion. All were in favor. Motion passed.
