Dr. Lee made a brief statement summarizing the objective of the proposed regulatory language, including an outline of a new proposed process for the intake of complaints. Additional discussion was held among Mr. Pontoni, Dr. Jahl, Dr. Lee, and Dr. Park regarding language details. Dr. Lee requested input from Committee members regarding the professional title of the clinical review position to be included in the regulatory language. Discussion ensued among Dr. Park, Dr. Lee, Dr. Jahl, Mr. Dworin, Ms.
