### 3. Public Workshop:

Notice of Public Workshop, Request for Comments and Review of Nevada Administrative Code Chapter 631, related to the changes to and/or additions to regulations:

- regarding administration of Board disciplinary proceedings pursuant to NRS 631.350-NRS 631.368;
- 2. Regulations regarding limited licensure permitting pursuant to NRS 631.271;
- 3. Hands-On Amendment to CPR Requirements pursuant to NRS 631.190;
- 4. Amendments to Continuing Education Audit Language pursuant to NRS 631.190;
- 5. Employment of Board Staff to be at-will pursuant to NRS 631.190.

The purpose of the workshop is to receive comments from all interested parties and to consider the proposed regulation changes to Nevada Administrative Code Chapter 631 and any potential amendments. The general topics include discussion consideration and possible approval/rejection of possible changes and/or additions to regulations regarding administration of Board disciplinary proceedings, anesthesia, and limited licensure permitting.

Dr. Lee introduced the first section, 3.1, provided a brief overview of the subject matter relating to disciplinary proceedings, and invited comments from Board members and the public.

Dr. Lee introduced the next section, 3.2, provided a brief overview of the subject matter relating to limited licensure, and invited comments from Board members and the public. Dr. Lemon had an inquiry regarding the wording of endorsement in the section containing AB 438. There was discussion among Dr. Lee, Dr. Lemon, and Ms. Romero clarifying the inclusion of AB 438 and that it had been included in the Book for background information as the initiation for section 3.1 on disciplinary proceedings. Dr. Lee offered further explanation for the proposed licensure regulation draft.

Dr. Lee introduced the next sections, 3.3, provided a brief overview of the subject matter relating to CPR requirements, and invited comments from Board members and the public. Dr. Thompson requested clarification regarding the hands-on language. There was brief discussion among Dr. Lee, Dr. Thompson, and Dr. Johl clarifying that the hands-on language was referencing CPR requirements only. Dr. Lemon requested clarification on the annual hours set forth in the language and Ms. Romero noted that the typo had been present in statute which was unchangeable by the Board.

Dr. Lee introduced the next section, 3.4, provided a brief overview of the subject matter relating to continuing education, and invited comments from Board members and the public.

Dr. Lee introduced the final section, 3.5, provided a brief overview of the subject matter relating to Board staff employment, and invited comments from Board members and the public.

Dr. Lee made a brief statement noting that the purpose of public workshops was to invite comments from the public and offered an opportunity for additional comments.

Dr. Moore made a brief comment thanking the Board for their work on regulatory matters and to Dr. Lee for his role.

4. Public Comment (Live public comment by teleconference): This public comment period is for any matter that is within the jurisdiction of the public body. No action may be taken upon the matter raised during public comment unless thematter itself has been specifically included on the agenda as an action item.
