5 Dr. Lee introduced the agenda item. The current CDC guidelines were updated on February 2, 2022, 6 and were adopted at the Board meeting held on March 15, 2022. There have been no further updates 7 to the CDC Interim Infection Prevention and Control Recommendations for Healthcare Personnel. There 8 was discussion as to their opinions on recommendations for lifting patient masking as to Nevada's 9 dental community. At the meeting held on March 15, 2022, the Board allowed for the practice owner 0 and/or dental director of any given practice location to determine patient masking requirements for 1 that location and that ultrasonic scaling is permitted pursuant to the CDC Interim Infection Control 2 Settings adopted by the Board. The recommendation was made to post an update on the Board's 3 website stating that the CDC guidelines from February 2, 2022, remains the most recent update 4 pertaining to COVID-19 protocols for healthcare personnel and have been referenced by the American 5 Dental Association on their website as well. It should be noted that according to the CDC website, the 6 CDC is "currently reviewing" these published guidelines, and if the CDC should provide updated 7 guidance the Board will notify licensees as soon as such information becomes available.

There was one public comment from Jannette Gomez, RDH. She would like to implement a statewide thirdgrade basic screening survey for the 2022 – 2023 school year. She is seeking approval from the Board to conduct the survey if her Public Health Endorsement does not suffice. The Association of State and Territorial Dental Directors (ASTDD) Basic Screening Survey is an oral health assessment for third graders to determine what the oral health needs are for children in the State of Nevada. The exam is conducted using only a disposable dental mouth mirror. Most states conduct the survey every five years, however the last survey conducted in Nevada was completed in 2008.

Mr. Dworin stated that no action can be taken by the Board at this time because this is not listed as an
 agenda item. He recommended that Ms. Gomez formally petition the Board requesting an advisory opinion

which can be added to the agenda for the next meeting.
