    - (1) Preservation and Regeneration of Periradicular Structure in Endodontic Microsurgery (3 Units) David M. Reeves, DDS
    - (2) Diode Lasers Standard Proficiency Course (6 Units) Midwest Dental
    - (3) Practice Leadership Conference (3 Units) Nicole Bui-Fong. DDS
  - 1) Dr. Kim moved to approve the course proposed by Dr. Reeves. Dr. Branco seconded the motion and the motion passed.
  - 2) Ms. Arias raised concerns regarding the correct speaker listed on the application. Dr. Kim clarified that the company and instructors are PACE-approved, but the application needs revision to list the correct speakers instead of a dental assistant. Dr. Kim motioned to approve the course on the condition that the application is resubmitted with the correct speakers before the next board meeting. Ms. Arias seconded the motion and all were in favor. The motion passed unanimously.
  - 3) Ms. Arias asked about credit allocation for participants and future dates. Dr. Kim explained that participants can earn a maximum of three credits annually, and new participants or changes in curriculum for future sessions would require re-approval. Dr. Kim moved to approve the course, which was seconded by Dr. Johl. The motion passed unanimously.
