2. Public Comment (Live public comment, by teleconference, and pre-submitted email/written form):

3. Public Workshop:

Notice of Public Workshop, Request for Comments and Review of Nevada Administrative Code Chapter 631, related to the changes to and/or additions to regulations pertaining to the following:

Teledentistry pursuant to AB 147.

The purpose of the workshop is to receive comments from all interested parties and to consider proposed regulation changes to Nevada Administrative Code Chapter 631 in conformance with AB 147. The general topics include discussion and consideration of possible changes and/or additions to regulations regarding teledentistry.

Dr. Jay Corsandi, Chief Dental Officer for Byte, urged the Board to adopt flexibility and deference to the independent judgment of practitioners when implementing the regulations pursuant to AB 147. Dr. Corsandi explained Byte's teledentistry protocols, emphasizing that each patient's treatment plan is reviewed by a Nevada-licensed dentist and that the dentist retains the right to declare the patient unfit for treatment. Dr. Corsandi expressed concerns about the ability to accurately diagnose and treat conditions like perio probing and endodontic issues through teledentistry.

Dr. West emphasizes the importance of comprehensive and baseline records for elective orthodontic treatments. Dr. Johl and Dr. Lee discussed the potential risks of teledentistry, including the inability to detect issues like necrotic teeth and perio problems without in-person exams. Dr. Corsandi acknowledged the concerns and explains that Byte's protocols include safeguards to ensure patient safety and effective treatment. Dr. Corsandi also highlighted Byte's commitment to working with the Board to enable access to care while maintaining high standards.

Eddie Abelser, a representative from Tri Strategies and the Nevada Dental Association, emphasized the importance of establishing a relationship between the patient and the dentist before teledentistry. Mr. Abelser also mentioned that the Nevada Dental Association has draft regulations for AB 147 and offered to share them with the Board for consideration.

Dr. Amy Abbottan, Secretary for the Nevada Dental Association, reiterated the association's commitment to patient protection and consistent care for all patients.
