Dr. Amy Abatan, secretary for the Nevada Dental Association (NDA), voiced her support of the proposed regulatory language submitted by Ms. Julie Muhle.

- *3. Chairman's Report: Ronald West, DMD (For Possible Action)
 - *a. Request to Remove Agenda Item(s) (For Possible Action)

Ms. McIntyre made a motion to approve the agenda. Dr. Johl seconded the motion and the motion passed.

- *4. New Business NRS 631.190: (For Possible Action)
 - *a. Review, Discuss and Consider proposed amendments, additions, and/or revisions to regulations in Nevada Administrative Code Chapter 631 (NAC 631) as it relates to expanded function dental assistance in conformance with SB 310.
 - *b. Make potential recommendations to the Board regarding proposed amendments, additions, and/or revisions to Nevada Administrative Code Chapter 631 (NAC 631).

Dr. Branco suggested the need for a list of acceptable prescriptions that hygienists can write, highlighting the open-ended nature of the law regarding systemic medications. Ms. McIntyre voiced her agreement in providing an inclusive list to reference. The committee agrees on a list of seven prescriptions that hygienists can write, including topical fluoride, oral antiseptic rinse, prescription fluoride, desensitizers, whitening gel, topical anesthetic, and medicant trays. The committee also agrees that only two expanded function dental auxiliaries (EFDAs) should be practicing as expanded function at one time, per dentist. After discussion between Ms. Muhle and Mr. Karris about the inclusion of clinical hours to ensure quality and supervision, the committee agrees that the Board should leave the supervision requirements to the discretion of the hiring dentist. Dr. Branco and Dr. Johl expressed

concerns about allowing EFDAs to perform certain procedures without direct supervision. The committee decided to list cementation of permanent restorations, placing and removing matrices, and applying bleaching agents as requiring direct supervision. Dr. West made a motion to recommend to the Board the recommendations mentioned in the discussion. Ms. McIntyre seconded the motion and all were in favor. The motion passed.

5. Public Comment (Live public comment and by teleconference): This public comment period is for any matter that is within the jurisdiction of the public body. No action may be taken upon the matter raised during public comment unless the matter itself has been specifically included on the agenda as an action item. Mr. Antonio Ventura proposed that the Board use the term "dental hygiene procedures" instead of "cleaning" when referring to removing cement from brackets, as it more accurately describes the work. Mr. Ventura also suggested that the fees for processing endorsement licenses should be lowered as they do not require the same amount of processing as initial licenses.

Ms. Muhle expressed support for requiring 12 Continuing Education (CE) hours annually, or 24 biennially, as this aligns with existing requirements for those with a Certified Dental Assistant (CDA) or certified restorative functions credential. Ms. Muhle also discussed the Board's requirement for a course approved by the Board covering identification, prevention, and management of medical and dental emergencies. Ms. Muhle ended by noting that her program has a comprehensive manual for handling emergencies but are willing to incorporate any additional board-approved training.
