Dr. Kim made a motion to approve the agenda, with Dr. Streifel seconding the motion. All were in favor and the motion passed.

- \*4. New Business: (For Possible Action)
  - \*a. Discussion, Consideration and Possible Recommendation to Board concerning education and training and continuing education for dental hygienists to be permitted to prescribe and dispense drugs NRS 631.3105; NRS 631.190 (For Possible Action)

Dr. Kim and Mr. Karris reviewed Continuing Education (CE) courses in other jurisdictions and found limited courses meeting Nevada's requirements and approached Dr. Gallup from UNLV School of Dental Medicine to help develop a CE course. Dr. Gallup discussed defining the scope of what dental hygienists can prescribe, including clarifying the limits of "systemic medications" under the law. A proposed list of permitted medications was discussed, including topical fluoride, oral antiseptics, desensitizers, and others. Clarification on whether systemic fluoride and athletic mouth guards should be included was also addressed. Dr. Gallup emphasized the need to define these limits to ensure hygienists are prescribing safely within their scope. The committee agreed that systemic medication should be limited to fluoride tablets, and mouth guards should be restricted to athletic purposes. Dr. Kim made a motion to instruct Dr. Gallup to develop a CE course for dental hygienists, focusing on fluoride tablets and athletic mouth guards, and submit it for review by the CE committee. The course will be evaluated by the main board for final approval. Dr. Johl seconded the motion, which passed unanimously.
